Whereas, the J&K Public Service Commission, vide Notification No. 17- PSC (DR-P) OF 2023 dated: 15.05.2023, advertised the said posts for selection; *and,*

Whereas, written test was conducted on 27.08.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/57 dated: 05.10.2023 in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; *and,*

Whereas, 32 candidates qualified for interview against Notification dated 01.03.2023 and 13 candidates against Notification dated 15.05.2023. Six (06) candidates were common to both of the Notifications. As such, only 39 candidates were called for interview; *and,*
